Disability Standard 2009

A unique management tool that shows you where you are on disability, where you need to be and how to get there.

Developed by Employers' Forum on Disability (EFD), the Disability Standard is the only management tool for employers, which accurately measures your performance on disability.

If you are committed to employing people on the basis of their ability, opening up new markets, improving the quality of customer care and minimising legal and reputational risk, you should take part in the Disability Standard 2009.

Organisations are asked to rate themselves against a number of statements and provide supporting evidence across all areas of the business including:

- employment and recruitment
- customer services and e-commerce
- occupational health and health & safety
- premises and the built environment
- IT systems
- accessibility of goods and services
- outsourcing and procurement
- corporate responsibility and brand reputation.

Submissions are analysed by disability experts and results are presented in individual diagnostic reports and collated for the overall benchmark.

Benefits

There are three main benefits to participating in the Disability Standard:

- A comprehensive diagnostic report on disability within your organisation, containing details of actions you can take to improve future performance.
- Best practice awards that celebrate your organisation’s commitment to disability confidence.
- Disability Standard 2009 benchmark that ranks your performance against all participants and by sector.

For public sector organisations the Disability Standard covers the Disability Equality Duty and Disability Equality Schemes.

Timescale

- Participants have 8 weeks from the beginning of March 2009 to compile evidence and submit online.
- Individual diagnostic reports and tailored debriefs are available from July 2009.
- Participants attend the 'Building disability confidence' event in the autumn and receive the Benchmark Report.
- The Awards ceremony is held in November 2009 to celebrate high performance and best practice achievement.
